**RELEASE OF SECURITY INTEREST (TRADEMARKS)**

This RELEASE OF SECURITY INTEREST (TRADEMARKS), dated as of May 20, 2014 ("Release"), is made by WEBSTER BANK, NATIONAL ASSOCIATION, a bank national association located at 185 Asylum Street, Hartford, Connecticut 06103 (the "Lender"), in favor of INSYNC MEDIA GROUP, LLC, a Delaware limited liability company located at 3731 N.W. 8th Avenue, Boca Raton, Florida 33431, INTERIOR DESIGN MEDIA GROUP, LLC, a Delaware limited liability company, located at 3731 N.W. 8th Avenue, Boca Raton, Florida 33431, MATERIAL CONNEXION, INC., a New York corporation located at 60 Madison Avenue, 2nd Floor, New York, New York 10010, SANDOW MEDIA, LLC, a Delaware limited liability company located at 3731 N.W. 8th Avenue, Boca Raton, Florida 33431, and WORTH MEDIA GROUP, LLC, a Delaware limited liability company located at 3731 N.W. 8th Avenue, Boca Raton, Florida 33431 (each, a "Grantor" and, collectively, the "Grantors"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below).

WHEREAS, pursuant to the Security Agreement, dated as of May 9, 2013 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), between the Lender and the Grantors, as security for the payment or performance, as applicable, in full of the Obligations, the Grantors collaterally assigned, mortgaged, pledged and hypothecated to the Lender, and granted to the Lender, a security interest in all of the right, title and interest of the Grantors in, to and under the Collateral, including, without limitation, certain of their intellectual property;

WHEREAS, each Grantor, pursuant to a separate Grant of Security Interest (Trademarks) dated as of May 9, 2013 (each, a "Grant of Security Interest (Trademarks)"), between the Lender and such Grantor, as security for the payment or performance, as applicable, in full of the Obligations, collaterally assigned, mortgaged, pledged and hypothecated to the Lender, and granted to the Lender, a security interest in all of such Grantor's right, title and interest in, to and under the following property, then owned or thereafter acquired (collectively, the "Trademark Collateral"):

- (a) trademarks and registrations thereof, including the trademarks listed on Schedule 1 attached hereto (collectively, the "Trademarks");
- (b) the goodwill of the business symbolized by the Trademarks; and
- (b) all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement thereof;

WHEREAS, each Grant of Security Interest (Trademarks) was recorded in the United States Patent and Trademark Office (the "PTO") on May 10, 2013, and appears at the following location in the PTO records:

WHEREAS, the Obligations have been paid and performed in full and the Lender has agreed to release its collateral assignment, mortgage, pledge, hypothecation and security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. The Lender hereby terminates each Grant of Security Interest (Trademarks), and hereby terminates, cancels and releases any and all collateral assignments, mortgages, pledges, hypothecations, and security interests that it has in, to and under the Trademark Collateral of each Grantor.

2. Authorization to Record. The Lender authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.

3. Further Assurances. The Lender shall take all further actions, and provide to the Grantors, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors to more fully and effectively effectuate the purposes of this Release, all at the sole expense of the Grantors.
