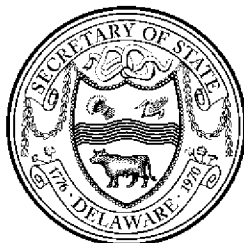

Pursuant to Title 8, Section 264 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

1. The name and jurisdiction of formation or incorporation of each of the constituent entities are Rush Tracking Systems, LLC, a Kansas limited liability company ("Rush") and TotalTrax, Inc., a Delaware corporation ("TotalTrax").
