WHEREAS, pursuant to that certain Trademark Security Agreement dated as of March 20, 2006, by and among Grantor, Administrative Agent and the other grantors party thereto (the "Security Agreement") recorded on March 20, 2006, on Reel No. 003272, Frames 0402 - 0443, United States Patent and Trademark Office, Grantor granted a security interest in certain trademarks in favor of Administrative Agent to secure certain obligations owing from Grantor to Administrative Agent under the Credit Agreement, dated as of March 20, 2006 (as amended, restated, supplemented or otherwise modified) (the "Credit Agreement") among Affiliated Computer Services, Inc. (the "Company"), certain Subsidiaries of the Company, the Lenders and Issuers party thereto and Citicorp USA, Inc. as agent for the Lenders and Issuers (such terms as defined in the Credit Agreement);

WHEREAS, pursuant to that certain letter dated as of February 5, 2010, (the "Payoff Letter") from the Administrative Agent to the Company, Obligations under the Credit Agreement have terminated and the Liens created by the Collateral Documents with respect to the Collateral have been released and discharged as of the Effective Date (such terms as defined in the Payoff Letter);

WHEREAS, Grantor has requested that Administrative Agent (i) terminate and release the liens and interests of Administrative Agent in certain of Grantor's trademarks as set forth in Exhibit A attached hereto (collectively, the "Trademarks"), and (ii) execute and deliver evidence

of such termination and release for filing in the United States Patent and Trademark Office and other appropriate offices; and

WHEREAS, Administrative Agent has agreed to such release and termination.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby releases and terminates its security interests in the Trademarks, and reassigns to Grantor all right, title and interest of Administrative Agent in and to the Trademarks.
