NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, Assignor hereby assigns to the Assignee, and Assignee accepts, full right, title and interest in the Application, including full right, title and interest, in any, in the underlying mark, together with that portion of Assignor's business, and the goodwill of the business, to which the Application and the underlying mark pertain, which business is ongoing and existing, and all rights of action and claims for past, present or future infringement *nunc pro tunc*, effective as of January 11, 2013.
