TRADEMARK ASSIGNMENT AGREEMENT

TRADEMARK ASSIGNMENT AGREEMENT ("*Assignment*") dated as of May __, 2014 ("*Effective Date*") by and between The Robot Report, a California sole proprietorship consisting of Frank L. Tobe, an individual resident of the state of California with an address at 3463 State Street, Suite 602, Santa Barbara, CA 93105 ("*Assignor*"), and Robo-Stox LLC, a Texas limited liability company with an address at 300 Crescent Court, Suite 840, Dallas, TX 75201 ("*Assignee*").

RECITALS

WHEREAS, Assignor owns the ROBO-STOX trademark, which is the subject of U.S. Reg. No. 4,355,753, together with the goodwill of the business associated therewith (collectively, the "*Trademark*"); and

WHEREAS, Assignor wishes to assign to Assignee and Assignee wishes to acquire from Assignor, the Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows.

- 1. Assignment.** Assignor does hereby assign to Assignee all of Assignor's right, title and interest in and to the Trademark, together with that portion of Assignor's business in connection with which it uses, or has an intent to use, the Trademark and the goodwill of the business symbolized by the Trademark, and with the right to sue for and recover damages and profits for any past, present, or future infringements of the Trademark.
- 2. Recordation.** Assignor hereby requests that the Commissioner for Trademarks, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Trademark.
- 3. Further Assurances.** Assignor shall take such further actions, and provide to Assignee, Assignee's successors, assigns and other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney or other documentation), reasonably requested by Assignee to more fully and effectively effectuate the purposes of this Assignment.
