RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this "Release") is made as of September 25, 2013, by PNC BANK, NATIONAL ASSOCIATION (as successor to National City Bank), a national association, as collateral agent (in such capacity as the "Collateral Agent"), the secured party under the Security Agreement referred to below.

WITNESSETH:

WHEREAS, Grand Traverse Band Economic Development Corporation ("Grantor") executed that certain Third Amended and Restated Intellectual Property Security Agreement, dated as of January 31, 2012 (together with the prior Intellectual Property Security Agreement that had been amended and restated, the "Security Agreement"), pursuant to which Grantor granted a security interest to the Collateral Agent in certain trademarks and other intellectual property of Grantor; and

WHEREAS, (1) a Grant of Security Interest -- Trademarks executed in connection with said Security Agreement was recorded with the United States Patent and Trademark Office at Reel 3395, Frame 0649 on September 21, 2006, and (2) a Grant of Security Interest -- Trademarks executed in connection with said Security Agreement was recorded with the United States Patent and Trademark Office at Reel 4709, Frame 0070 on February 1, 2012; and

WHEREAS, the Collateral Agent has agreed to release its lien on the trademarks of Grantor identified on Exhibit A attached hereto and made a part hereof (the "Released Collateral").

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby releases all its rights in and to the Released Collateral and reconveys to the persons legally entitled thereto all of the Collateral Agent's right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.


