This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of May 21, 2014, is made by GENERAL ELECTRIC CAPITAL CORPORATION, as agent and collateral agent under the Credit Agreement (in such capacity, the "Agent"). Terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement, as applicable.

WHEREAS, in connection with that certain Credit Agreement, dated as of July 15, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Contessa Premium Foods, Inc. (the "Borrower"), Premium Foods Group Holdings Corp. (the "Holdings"), the Lenders and the L/C issuers from time to time party thereto and Agent for the Lenders and the L/C Issuers, the Lenders and the L/C Issuers agreed to make extensions of credit to the Borrower;

WHEREAS, each Grantor (other than the Borrower) has agreed, pursuant to a Guaranty and Security Agreement in favor of the Agent (the "Guaranty and Security Agreement") to guarantee the Obligations of the Borrower;

WHEREAS, in connection with the Credit Agreement, Security Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "Security Agreements"), the Grantors granted security interests in certain intellectual property owned by the Grantors, including those listed on Annex I attached hereto (collectively, the "Intellectual Property Collateral"); and

WHEREAS, the Security Agreements were recorded in the U.S. Patent and Trademark Office, as applicable, on the dates and on the reels and frames set forth on Annex I hereto;

NOW THEREFORE, the Agent hereby releases, without representation, recourse or warranty whatsoever, all of their security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Intellectual Property Collateral to the Grantors. The Agent agrees, at the expense of the Grantors, to cooperate with the Grantors and to provide the Grantors with the information and additional authorization reasonably required to effect the release of the Agent's security interests in the Intellectual Property Collateral.
