RELEASE AND TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE AND TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Release") by Rabobank, N.A. ("Bank") is effective as of May 9, 2014.

WHEREAS, on or about December 28, 2007, Bank made a term loan to Sun World International, LLC, a Delaware limited liability company ("Borrower") pursuant to that certain Credit Agreement by and between Borrower and Bank dated as of December 28, 2007 (as amended from time to time); and

WHEREAS, as security for the loan, Borrower executed and delivered to Bank an Intellectual Property Security Agreement dated as of December 28, 2007, pursuant to which Borrower granted to Bank a security interest in all of its right, title, and interest in the intellectual property described therein (the "IP Security Agreement"); and

WHEREAS, the Bank has agreed to terminate the IP Security Agreement and release any interest it has in the intellectual property described therein.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Bank does hereby release and terminate absolutely and unconditionally the IP Security Agreement and release any and all of Bank's right, title, and interest in the intellectual property described in the IP Security Agreement.

2. This Release shall be binding upon and inure to the benefit of Bank and its successors, assigns, and administrators. This Release has been executed in, and shall be governed by the laws of the State of California without reference to any conflict of laws principles, and any litigation arising out of or in connection with this Release shall be adjudicated in the State of California, applying California law. If any severable provision of this Release is held to be invalid or unenforceable by any judgment of a court of competent jurisdiction, the remainder of this Release shall not be affected by such judgment, and the Release shall be carried out as nearly as possible according to the original terms and intent. The foregoing constitutes the entire agreement of the parties as to the subject matter hereof.
