

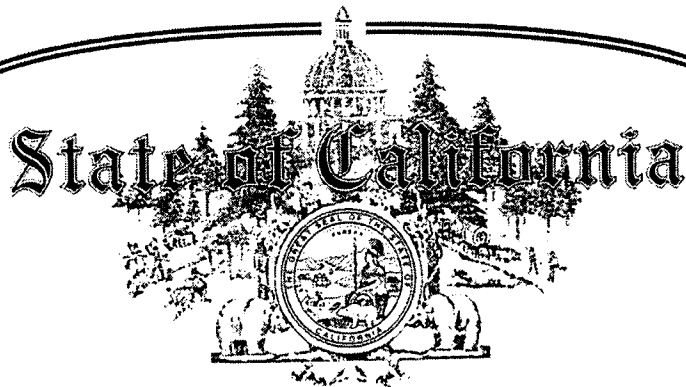

Pursuant to Section 92A.200
of the Nevada Revised Statutes

Each of Avalar Network, Inc., a California corporation ("Avalar California"), and Avalar Network, Inc., a Nevada corporation ("Avalar Nevada"), does hereby certify and state that:

FIRST: That Avalar Nevada was organized under the laws of the State of Nevada and that Avalar California was organized under the laws of the State of California.

SECOND: That an Agreement and Plan of Merger (the "Merger Agreement"), dated as of May 30th, 2003 among Avalar Nevada and Avalar California setting forth the terms and conditions of the merger of Avalar California with and into Avalar Nevada (the "Merger") has been approved and adopted by each of the constituent corporations.

THIRD: That the Merger Agreement was approved by the required written consent of the stockholders of Avalar California.

FOURTH: There is no stock issued in Avalar Nevada prior to the Merger, accordingly, approval of the Merger Agreement is not required by its stockholders.

FIFTH: That Avalar Nevada shall be the surviving corporation (the "Surviving Corporation") in the Merger and shall retain the name Avalar Network, Inc. Service of process may be sent to 9421 Verlane Court, Las Vegas, Nevada 89117.

SIXTH: That pursuant to the Merger Agreement, the Articles of Incorporation and Bylaws of Avalar Nevada shall be the Articles of Incorporation and Bylaws of the Surviving Corporation.

SEVENTH: That an executed copy of the Merger Agreement is on file at the registered office of the Surviving Corporation at the following address: 9421 Verlane Court, Las Vegas, Nevada, 89117.

EIGHTH: That a copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of any constituent corporation.
