TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This TERMINATION AND RELEASE dated as of May 28, 2014, from ONEWEST BANK N.A. (formerly known as OneWest Bank, FSB) (the "Lender") to SPECULATIVE PRODUCT DESIGN, LLC, a California limited liability company (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to that certain Security Agreement dated as of May 20, 2011, the Grantor has executed a Grant of Trademark Security Interest, and recorded solely in the United States Patent and Trademark Office at Trademark Reel 004547 Frame 0211 (the "Grant of Security Interest");

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Collateral pursuant to the Grant of Security Interest, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Lender hereby fully and finally terminates, releases and discharges the Security Interest, and all other rights in, to and under the Collateral.







