## TRADEMARK ASSIGNMENT



3. This Assignment includes the right to recover all damages for infringement of the Mark, whether such infringement occurred in the past or occurs in the future, as fully as if Assignor had filed such action in its own name. Further, Assignor agrees to cooperate in any such actions to the extent reasonably required by Assignee to enforce the rights transferred hereunder.
