 BUSINESS CORPORATION

2. The text of each amendment adopted is as follows:

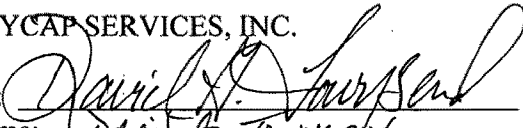
The Articles of Incorporation are amended by deleting Item no. 1 in its entirety and by substituting therefor the following Item no. 1.
