Assignor hereby authorizes Assignee to file this Agreement with the USPTO to record Assignee as the owner of THE DEAD RABBIT Registration.

Assignor shall take all further actions, and provide to Assignee, its successors, assigns or other legal representatives, all such cooperation and assistance consistent with this Agreement, with all actual costs paid by Assignee, but without any further compensation to Assignor.
