TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of May 30 2014, and made by ORIX CORPORATE CAPITAL INC. (formerly known as ORIX Finance Corp.), in its capacity as agent for the Lenders ("Grantee") to EVENT PHOTOGRAPHY GROUP HOLDING COMPANY, INC. (successor in interest to Event Photography Group, Inc., Bob Knight Photomarketing, Inc. and Chappell Studio, Inc.), a Delaware corporation ("Grantor").

WHEREAS, pursuant to that certain First Amendment to Trademark Security Agreement dated as of November 17, 2009 made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on November 30, 2009, at Reel 004104 and Frame 0701; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantor's right, title and interest in, to and under the following: (a) all of the Grantor's trademarks, trademark applications, service marks, trade names, mask works and associated goodwill (collectively, "Trademarks"), and licenses for any of the foregoing ("Licenses"), including those referred to on Schedule A hereto; (b) all reissues, continuations, continuations-in-part, substitutes, extensions or renewals of and improvements on the foregoing; and (c) all products and proceeds of the foregoing, including any claim by Grantor against third parties for past, present or future infringement or dilution of any Trademark or any Trademark licensed under any License.

2. Release of Security Interest. Grantee hereby terminates releases and discharges its security interest in the Trademark Collateral granted pursuant to the Security Agreement and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark Collateral that was granted to Grantee pursuant to the Security Agreement.
