**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

WHEREAS **Albaugh, Inc.**, an Iowa corporation with its principal office at 1525 NE 36<sup>th</sup> Street, Ankeny, Iowa 50021 (the "Grantor"), entered into that certain Security and Pledge Agreement dated April 22, 2013 (the "Trademark Security Agreement") with **Bank of America, N.A.**, as Administrative Agent, with its principal office at 901 Main Street, Mail Code TX1-492-14-06, Dallas, Texas 75202 (the "Administrative Agent"), notice of which was recorded on May 8, 2013 at the United States Patent and Trademark Office at Reel 5023, Frame 0346.

WHEREAS, Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the "Security Interest") in favor of the Administrative Agent, in and to certain of Grantor's intellectual property, including without limitation the trademarks listed on **Schedule A** (collectively, the "Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, as well as all proceeds and claims based on past, present, or future infringement.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the intellectual property of the Grantor, including the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest and any other liens, without recourse and without representation or warranty of any kind (express or implied).
