**RELEASE OF SECURITY INTEREST  
IN UNITED STATES PATENTS AND TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN UNITED STATES PATENTS AND TRADEMARKS** (this “Release”) is made as of May 23, 2014 (this “Release”) by BANK OF AMERICA, N.A., as Collateral Agent (the “Grantee”) in favor of Steinway Musical Instruments, Inc., a Delaware corporation, Conn-Selmer, Inc., a Delaware corporation, Arkivmusic, LLC, a New York limited liability company, and Steinway, Inc., a Delaware corporation (collectively, the “Grantors”). Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Pledge and Security Agreement (as defined below).

**WHEREAS**, each Grantor is party to a Second Lien Pledge and Security Agreement, dated as of September 19, 2013 (as amended, restated, supplemented, modified or otherwise changed from time to time, the “Pledge and Security Agreement”), in favor of the Grantee pursuant to which each Grantor executed and delivered to Grantee that certain Grant of Security Interest in United States Patents and Trademarks, dated as of September 19, 2013 (the “Grant of Security Interest in United States Patents and Trademarks”);

**WHEREAS**, pursuant to the terms and conditions of the Pledge and Security Agreement and Grant of Security Interest in United States Patents and Trademarks, each Grantor granted a security interest in all the Grantor’s right, title, and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the “Patent and Trademark Collateral”), whether presently existing or hereafter arising or acquired:

- (i) each United States patent and patent application, including each Patent and Patent Application referred to on Schedule A hereto;
- (ii) each United States trademark, trademark registration and trademark application, and all of the goodwill of the business connected with the use of, and symbolized by, each trademark, trademark registration and trademark application, including each Trademark, Trademark Registration and Trademark Application referred to in Schedule B hereto; and
- (iii) all products and proceeds of the foregoing, including any claim by the Grantors against third parties for past, present or future infringement of any Patent, or past, present or future infringement or dilution of any Trademark or Trademark registration, including any Patent or Trademark listed on Schedule A or B hereto, or for injury to the goodwill associated with any Trademark or Trademark registration;

**WHEREAS**, the Grant of Security Interest in United States Patents and Trademarks was recorded with the United States Patent and Trademark Office on September 23, 2013 at Reel/Frame 5116/0198 and 31290/0235; and

**WHEREAS**, the Grantee has agreed to terminate and release the security interest in the Patent and Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. The Grantee hereby terminates and releases in its entirety its security interest in all the Grantor’s right, title, and interest in, to and under the Patent and Trademark Collateral, and reassigns to such Grantor any and all right, title and interest it may have in such Patent and Trademark Collateral.

2. This Release may be executed in one or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument. Delivery by telecopier, .pdf or other electronic imaging means of an executed counterpart of a signature page to this Release shall be effective as delivery of an original executed counterpart of this Release.


3. The Grantee authorizes and requests that the Commissioner for Patents and Trademarks and any other applicable government officer record this Release.
