**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS**

This is a Release of Security Interest in Intellectual Property Rights (“Release”), entered into this 23rd day of March, 2014; and intended to be effective *nunc pro tunc* as of the 26th day of October, 2007 (the “Effective Date”) by:

**Bank of America NA, on behalf of LaSalle Bank National Association**, a national banking association (the “Administrative Agent” for the benefit of itself and other Lenders);

in favor of:

**Cloud Packaging Solutions, LLC (formerly Cloud, LLC)** a Delaware limited liability company (the “Debtor”);

WHEREAS, the Administrative Agent and Debtor entered into an agreement titled *Loan Agreement*, dated June 17, 2003 (the “Loan Agreement”) and the accompanying short-form agreement titled *Trademark Security Agreement* (the “Trademark Agreement”), which was recorded with the United States Patent and Trademark Office on June 18, 2003 at Reel/Frame No.: 002771/0339, and updated in the *First Amendment to the Trademark Agreement*, by and between Debtor and the Administrative Agent, dated December 18, 2003 (the “Amended Trademark Agreement”), which was filed with the United States Patent and Trademark Office on January 12, 2004, at Reel/Frame No.: 002896/0083, with respect to the Lender’s rights in the Trademark Collateral, as that term is defined in the Trademark Agreement, including those trademarks depicted in United States trademark registrations and applications listed on **Exhibit A** (the “Trademarks”);

WHEREAS, the capitalized terms used, but not defined, herein are defined in the Trademark Agreement; and

WHEREAS, the Administrative Agent and Debtors have terminated the Loan Agreement, Trademark Agreement and Amended Trademark Agreement as of the Effective Date, thereby releasing the security interest in certain assets of the Administrative Agent created therein, and assigning any rights Administrative Agent may have acquired in such assets, including Trademarks, back to Debtors.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent agrees as follows:

1. The Loan Agreement, Trademark Agreement and Amended Trademark Agreement are hereby terminated, the security interest created therein is released in its entirety, and any rights of the Administrative Agent in the Trademarks are assigned to Debtors without any representations or warranties as to title or any other matter whatsoever.

2. Debtors presently and hereafter hold title to the Trademarks in the same manner as would have been the case if the Loan Agreement, Trademark Agreement and Amended Trademark Agreement had never been entered into.
3. Any provision of this Release which is invalid, illegal, or unenforceable in any jurisdiction shall, as to that jurisdiction, be ineffective only to the extent of such invalidity, illegality, or unenforceability, and shall not in any manner affect the remaining provisions hereof in such jurisdiction or render any other provision of this Release invalid, illegal, or unenforceable in any other jurisdiction.
4. This Release shall be binding upon Administrative Agent and its respective successors and assigns, and shall inure to the benefit of the Debtors and Debtors' heirs, administrators, successors and assigns.
5. Except to the extent governed by United States Federal law, this Release shall be governed by and interpreted in accordance with the laws of the State of Illinois, without regard to the conflict of laws principles thereof.
