RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, VICTOR OOLITIC STONE COMPANY, an Indiana corporation ("Grantor"), granted a security interest in and lien upon certain trademarks and related rights of Grantor to BMO HARRIS BANK, N.A., a national banking association, as agent (in such capacity "BMO Harris") as set forth in that certain Trademark Collateral Agreement dated as of February 3, 2012, by Grantor in favor of BMO Harris (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Collateral Agreement"), a copy of which was recorded in the United States Patent and Trademark Office (the "USPTO") on February 8, 2012, at Reel No. 4713, Frame Nos. 736-741;

WHEREAS, BMO Harris assigned all of its right, title and interest under the Trademark Collateral Agreement to INDIANA COMMERCIAL FINANCE, LLC, a Delaware limited liability company ("Secured Party"), pursuant to that certain Assignment of Trademark Collateral Agreement dated as of January 30, 2014, by BMO Harris in favor of Secured Party (the "Assignment"; collectively, the Assignment and the Trademark Collateral Agreement are referred to herein as the "Trademark Security Documents"), a copy of which was recorded in the USPTO on February 1, 2014, at Reel No. 5206, Frame Nos. 100-103;

WHEREAS, Grantor has requested that Secured Party release its interest in the trademarks of Grantor.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. Releases any and all liens, security interests, right, title and interest of Secured Party granted pursuant to the Trademark Security Documents in the trademarks of Grantor, including, without limitation, those trademarks listed on Exhibit A attached hereto, together with the goodwill of the business symbolized by such trademarks, without recourse or representation or warranty, express or implied, of any kind;
2. Agrees that any power of attorney or similar rights granted by Grantor to Secured Party under the Trademark Security Documents are terminated; and
3. Authorizes and requests that the USPTO note and record the existence of the release hereby given.


