## RELEASE OF TRADEMARK SECURITY INTERESTS

This RELEASE OF TRADEMARK SECURITY INTERESTS (this "*Release*") is made as of May 12, 2014, by ROYNAT BUSINESS CAPITAL, INC., a Delaware corporation in its capacity as agent for the Lenders (in such capacity, "*Secured Party*"), in favor of GLAZER-KENNEDY INSIDER'S CIRCLE, LLC, a Delaware limited liability company (the "*Company*").

### RECITALS

A. The Company entered into that certain Trademark Security Agreement, dated as of March 1, 2011 (the "*Trademark Security Agreement*"), pursuant to which it granted Secured Party a security interest, for its benefit and for the ratable benefit of each Lender, in all of the Company's right, title, and interest in and to the trademarks and trademark licenses identified on *Schedule I* attached hereto (the "*Trademarks*"), all reissues, continuations, extensions, products and proceeds thereof, and all goodwill of the business associated therewith. Capitalized terms used herein without separate definition have the meanings ascribed to them in the Trademark Security Agreement.

B. The United States Patent and Trademark Office (the "*USPTO*") recorded the assignment of the Trademarks and the Trademark Security Agreement on March 2, 2011 at Reel/Frame: 4488/0842.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

### AGREEMENT

1. Secured Party hereby irrevocably terminates, discharges, cancels, and releases its continuing security interest in all of Secured Party's right, title, and interest in and to the Trademark Collateral, including, without limitation, in those items listed on Schedule I hereto, and reassigns and transfers any right, title, and interest that Secured Party may have in the Trademark Collateral to the Company.

2. Secured Party agrees to take all further actions as reasonably requested by the Company to more fully and effectively effectuate the purposes of this Release, all at the expense of the Company.

3. Secured Party hereby consents to the recording of, and hereby authorizes the Company, or the Company's authorized representative, to record this Release with the USPTO.
