This letter is the official certification of the Office of the Comptroller of the Currency (OCC) for Bank of Kansas, South Hutchinson, Kansas to be merged with, into, and under the title and charter number of Stillwater National Bank and Trust Company, Stillwater, Oklahoma, Charter Number 5347. The transaction was effective as of the date of this letter.

In addition, the OCC has received your letter concerning the title change and the appropriate amendment to the Articles of Association. The OCC has recorded that as of November 15, 2013, the title of Stillwater National Bank and Trust Company, Stillwater, Oklahoma, Charter Number 5347, changed to **Bank SNB, National Association**.

As a result of the Garn-St. Germain Depository Institutions Act of 1982, the OCC is no longer responsible for the approval of national bank name changes, nor does it maintain official records on the use of alternate titles. The use of other titles or the retention of the rights to any previously used title is the responsibility of the bank's Board of Directors. Legal counsel should be consulted to determine whether or not the new title, or any previously used title, could be challenged by competing institutions under the provisions of federal or state law.
