## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”), dated as of June 2, 2014, is executed by WILMINGTON TRUST, NATIONAL ASSOCIATION, a national banking association, as administrative agent and collateral agent (in such capacity, “Agent”) for the benefit of each of the Lenders (as defined in the Trademark Security Agreement, referred to below) in favor of METOKOTE CORPORATION, a Delaware corporation (“Grantor”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Trademark Security Agreement.

### RECITALS

A. WHEREAS, Grantor has, pursuant to a Guaranty and Security Agreement, dated September 30, 2013 (the “Guaranty Agreement”) and a Trademark Security Agreement, dated September 30, 2013 (the “Trademark Security Agreement”), recorded in the United States Patent and Trademark Office on October 3, 2013, at Reel 005124, Frame 0918, granted to Agent (for the benefit of each Lender) a security interest in and to all of Grantor’s right, title and interest in and to the Trademark Collateral, including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the “Released Collateral”); and

B. WHEREAS, Agent, on behalf of each Lender, wishes to release, without representation or warranty, its security interest in and to the Released Collateral as provided in this release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of each Lender, hereby releases, without representation or warranty, its security interest in and to the Released Collateral and terminates the Trademark Security Agreement. Agent acknowledges that this Release may be filed along with any other necessary documentation with the United States Patent and Trademark Office or any other governmental office to evidence the release granted herein at the sole expense of Grantor.
