
DECLARATION

I, Michael Rawlings, do hereby declare under penalty of perjury, 18 U.S.C. § 1001, that all statements made herein made of my own knowledge are true and all statements made on information and belief are believed to be true.

1. I am Vice President of Finance of Allfast Fastening Systems, Inc., a California corporation ("Allfast"), and as such have authority to make the statements set forth herein on behalf of Allfast.
2. Allfast is the owner of certain intellectual property rights, including the trademark registrations set forth in Exhibit A attached hereto (collectively, the "Intellectual Property").
3. It is my understanding from review of documents filed and recorded with the United States Patent & Trademark Office ("USPTO") that the following facts are relevant to the chain of title of the Intellectual Property.
4. As security for a loan (the "Loan") made in connection with certain financing agreements with Coastfed Business Credit Corporation (the "Lender"), Allfast granted a security interest in the Intellectual Property to the Lender.
5. The grant of the security interest to the Lender was recorded at the USPTO on April 24, 1987 at Trademark Reel/Frame 0561/0528.
6. In 1990, the Company repaid all outstanding indebtedness under the Loan and terminated the Loan pursuant to a letter dated August 7, 1990 from the Company to the Lender (copy attached hereto as Exhibit B).
7. In a letter dated December 20, 1990 from the Lender to the Company, the Lender confirmed that the Company fully satisfied all obligations to the Lender (copy attached hereto as Exhibit C).
8. When the Loan was terminated, a release of the security interest in the Intellectual Property was not obtained from the Lender and recorded with the USPTO.
9. It appears that the Lender subsequently consummated a merger transaction with Southern Pacific Thrift and Loan Association, which subsequently changed its name to Southern Pacific Bank and was closed by the California Division of Financial Institution in February 2003.
10. Based upon the facts that the security interest granted to the Lender was granted in 1987, Allfast repaid all outstanding indebtedness under the Loan and terminated the Loan pursuant to a letter dated August 7, 1990, the Lender confirmed that the Company fully satisfied all obligations to the Lender in a letter dated December 20, 1990, and, to the best of Allfast's knowledge, neither the Lender nor its successor-in-interest has ever contacted Allfast regarding payments

or outstanding indebtedness, Allfast confirms that the Lender no longer has a valid security interest in the Intellectual Property.

11. Allfast is therefore filing this declaration as evidence of its belief and understanding that Allfast paid off its indebtedness to the Lender such that the Lender's security interest in the Intellectual Property has been fully released.

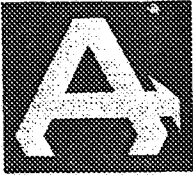


