**RELEASE OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** (this “**Release**”), dated as of June 5, 2014, is made by Bank of America, N.A., as Collateral Agent (the “**Collateral Agent**”) under the Pledge and Security Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Pledge and Security Agreement).

WHEREAS, in connection with that certain Pledge and Security Agreement dated as of May 30, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the “**Pledge and Security Agreement**”), among Harness Acquisition Company, LP, Elbrus Merger Sub, Inc., ECI Holdco, Inc., Electrical Components International, Inc., Noma O.P., Inc. (“**Noma**”), the other Subsidiary Guarantors from time to time party thereto and the Collateral Agent, and pursuant to that certain agreement described on Annex I attached hereto (the “**Trademark Security Agreement**”), Noma granted a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement) of Noma, including the trademarks listed on Annex I attached hereto (the “**Intellectual Property Collateral**”); and

WHEREAS, the Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on the date and on the reel and frame set forth on Annex I hereto.

NOW THEREFORE, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby releases, terminates and discharges, without representation, recourse or warranty whatsoever its security interest in, to and under the Intellectual Property Collateral.

The Collateral Agent agrees, at Noma’s expense, to cooperate with Noma, or Noma’s authorized representative, and to provide Noma with the information and additional authorization reasonably required or desirable to effect the release of the Collateral Agent’s security interest in the released collateral described herein.


The Collateral Agent authorizes and requests that the Commissioner for Patents and Trademarks and any other applicable government officer record this Release.

THIS AGREEMENT SHALL BE GOVERNED BY THE INTERNAL LAWS OF THE STATE OF NEW YORK (INCLUDING, WITHOUT LIMITATION, SECTION 5.1401 OF THE GENERAL OBLIGATIONS LAW OF THE STATE OF NEW YORK).
