TRADEMARK ASSIGNMENT

Flexjet, LLC, a Delaware limited liability company ("Assignor"), has adopted and used the trademarks set forth on Schedule A (including all related registrations and applications for registration, the "Marks"). Sentient Jet Charter, LLC, a Delaware limited liability company ("Assignee") wishes to acquire all of Assignor's rights in the Marks. Accordingly, Assignor and Assignee agree as follows:

1. Assignment. In exchange for consideration in the amount of \$1.00, Assignor assigns and transfers to Assignee all of Assignor's right, title, and interest in and to the Marks, including without limitation (a) the goodwill symbolized by and associated with the Marks; and (b) all rights of any kind accruing under the Marks provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world, and (c) any and all claims and causes of action with respect to the Marks, whether accruing before, on or after the date of this Trademark Assignment.

2. Recordation and Further Actions. Assignor authorizes the Commissioner for Trademarks and any other applicable governmental officials to record and register this Trademark Assignment upon Assignee's request. Assignor will execute and file such additional documents take all other reasonable actions as may be required to vest full title in the Marks to Assignee.


3. General Provisions. This Trademark Assignment will be governed by and construed in accordance with the laws of the State of Ohio without reference to its choice of law rules. This Trademark Assignment may be executed in counterparts, each of which will be deemed an original, but all of which together will be deemed to be one and the same agreement. This Trademark Assignment is binding upon and will inure to the benefit of Assignor, Assignee and their respective successors and assigns.
