

**AND**, Allivictus USA **HEREBY** authorizes and requests the Commissioner of Trademarks of the United States and any official of any foreign country whose duty it is to issue, assign, and/or record as assignee for all trademarks to Allivictus, s.r.o., its successors and assigns, in accordance with the terms of this Assignment;

**AND**, Allivictus USA **HEREBY** further covenants that Allivictus USA has the full right to convey the interest assigned by this Assignment.

Allivictus, s.r.o. will take all action and execute all documents necessary to perfect the interest assigned hereby, and Allivictus USA has not executed and will not execute any agreement in conflict with this Assignment;
