RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS AND PATENTS

May 29, 2014

WHEREAS, ZALE CORPORATION, a Delaware corporation (“**Zale**”) and each of the entities listed on **Schedule A** attached hereto (individually, a “Grantor” and together with Zale, the “**Grantors**”) granted a security interest to Z INVESTMENT HOLDINGS, LLC, as collateral agent (the “**Administrative Agent**”) in and lien upon certain trademarks as set forth in (a) that certain Patent, Industrial Design and Trademark Security Agreement dated May 10, 2010 by the Grantors in favor of the Collateral Agent (the “**2010 IP Security Agreement**”) and (b) that certain Patent, Industrial Design and Trademark Security Agreement dated July 24, 2012 by the Grantors in favor of the Collateral Agent (the “**2012 IP Security Agreement**” and, together with the 2010 IP Security Agreement, the “**IP Security Agreements**”) which 2012 IP Security Agreement was recorded in the United States Patent and Trademark Office (a) at Reel 028640, Doc. No. 499 and in a corrective filing at Reel 30658, Doc. No. 0595, with respect to the patents covered thereby, and (b) at Reel 004828, Frame 0951 and in a corrective filing at Reel 005051, Frame 0216, with respect to the trademarks covered thereby;

WHEREAS, the Grantors have requested that the Collateral Agent release and reassign to Grantors their interest in the trademarks and patents subject to the IP Security Agreements, including, but not limited to, the trademarks and patents identified in **Schedule B** hereto and made a part hereof; and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Collateral Agent hereby:

1. releases and reassigns to Grantors any and all liens, security interests, right, title and interest of Collateral Agent arising pursuant to the IP Security Agreements in the trademarks and patents identified in the IP Security Agreements, including, but not limited to, all liens, security interests, right, title and interest in the trademarks and patents identified in **Schedule B** and/or any goodwill associated with any of the trademarks subject to the IP Security Agreements or identified in **Schedule B**, without recourse or representation or warranty, express or implied of any kind; and

2. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the releases hereby given.
