of its Collateral (as defined in the Fourth Supplemental Trademark Security Agreement); and

WHEREAS, pursuant to the terms of that certain Trademark Security Agreement dated as of May 31, 2013 (the "Fifth Supplemental Trademark Security Agreement"), by and between the Bank and Cruz Bay, as filed with the Assignment Division at the United States Patent and Trademark Office on June 4, 2013 at Reel 005040, Frame 0469, Cruz Bay granted to the Bank a security interest in and lien on all of its Collateral (as defined in the Fifth Supplemental Trademark Security Agreement); and

WHEREAS, pursuant to the terms of that certain Trademark Security Agreement dated as of August 22, 2013 (the "Sixth Supplemental Trademark Security Agreement"), by and between the Bank and Cruz Bay, as filed with the Assignment Division at the United States Patent and Trademark Office on October 7, 2013 and at Reel 005126, Frame 0250, Cruz Bay granted to the Bank a security interest in and lien on all of its Collateral (as defined in the Sixth Supplemental Trademark Security Agreement); and

WHEREAS, the Bank wishes to release the security interest in and lien on the all of the Collateral, including, without limitation, the trademarks identified on Schedule A, attached hereto.
