Secretary's Certificate

I, Thomas J. Gallagher, hereby certify that I am the duly appointed and qualified Secretary of Bull HN Information Systems Inc., a corporation organized and existing under and by virtue of the laws of the State of Delaware, United States of America, and that the following is true and correct:

On March 26, 1987, Compagnie des Machines Bull ("CMB") acquired 42.5% of the capital stock of Honeywell Information Systems Inc. (whose name was changed to Honeywell Bull Inc. and now known as Bull HN Information Systems Inc.) with the balance being owned by Honeywell Inc. (42.5%) and NEC (15%).

On December 29, 1988, Compagnie des Machines Bull purchased 22.6% of Honeywell Bull Inc. from Honeywell Inc. resulting in ownership by CMB of 65.1%, Honeywell Inc. of 19.9% and NEC of 15%.

On January 26, 1989, Honeywell Bull Inc. changed its name to Bull HN Information Systems Inc.

On April 12, 1991, Honeywell Inc. sold its remaining sharehold interest in Bull HN Information Systems to CMB resulting in ownership by CMB of 85% and NEC of 15%

On October 30, 1991, NEC sold its sharehold interest in Bull HN to CMB resulting in 100% ownership of Bull HN by Compagnie des Machines Bull.

The amendment to the Company's Restated Certificate of Incorporation set forth in the following resolution approved by the Company's Board of Directors was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.

RESOLVED, That at the time Honeywell Inc. sells the "Option Amount" of Company shares to Compagnie des Machines Bull pursuant to Section 5.1 of the Shareholders Agreement, Paragraph 3, Section FIRST of the Restated Certificate of Incorporation of the Company shall be amended to read as follows:

"FIRST: The name of the corporation (the "Company") is Bull HN Information Systems Inc."

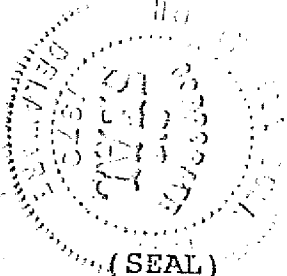
It is further certified that Honeywell Inc. has sold the "Option Amount" of the Company's shares to Compagnie des Machines Bull; and
