TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT dated as of April 24, 2014, 2014 is executed for the benefit of Davaco Holdings, Inc. and Davaco, Inc. 

1. The Lender hereby terminates and releases its security interest in and first priority lien on all of the Named Trademarks.
2. This Termination and Release of Trademark Security Agreement is also intended to operate as a release of the Security Agreement by Lender.
