ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

This ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS (this "Agreement") is made as of this 9th day of June, 2014 between ABACUS FINANCE GROUP, LLC, as Administrative Agent for itself and certain lenders (hereinafter referred to as the "Assignor") and GOLUB CAPITAL LLC, as Administrative Agent for itself and certain lenders (hereinafter referred to as the "Assignee").

WITNESSETH

WHEREAS, that certain Trademark Security Agreement (as amended from time to time, "Security Agreement") dated as of April 25, 2013, was entered into by and among BioreclamationIVT, LLC (formerly known as Bioreclamation, LLC) (the "Grantor"), and Assignor, and was recorded in the records of the United States Patent and Trademark Office at Trademark Reel 5019, Frame 0132;

WHEREAS, pursuant to the Security Agreement, Grantor granted Assignor a security interest in certain of Grantor's assets, including, without limitation, the trademarks and trademark applications set forth on the Schedule attached hereto;

WHEREAS, Assignor desires to assign, and Assignee desires to take by assignment, all of Assignor's rights and obligations in, to and under the Security Agreement;

WHEREAS, Assignor and Assignee entered into that certain Amendment No. 3 to Amended and Restated Credit Agreement and Agency Transfer Agreement ("Assignment Agreement") dated as of the date hereof, with respect to Assignor's assignment to Assignee of, among other things as expressly set forth therein, Assignor's rights under the Security Agreement;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:


1. Assignor hereby assigns to Assignee, and Assignee hereby assumes and undertakes from Assignor, without recourse and without representation or warranty, except as otherwise expressly provided in the Assignment Agreement, Assignor's entire right, title and interest in, to and under the Security Agreement.

2. This Agreement may be executed in any number of counterparts and all of such counterparts taken together shall be deemed to constitute one and the same instrument.

3. This Agreement shall be governed by and construed in accordance with the laws of the state of New York.


