RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This Release of Security Interest in Trademark Collateral is made this 30th day of May, 2014 (“Effective Date”), by PNC BANK NATIONAL ASSOCIATION, as administrative agent, for the ratable benefit of the Secured Parties, (in such capacity, the “Administrative Agent”) for the holders of the Obligations (as defined in the Credit Agreement) (such holders, the “Secured Parties”), in favor of ALCO INDUSTRIES, INC., a Delaware corporation, MODERN EQUIPMENT COMPANY, a Wisconsin corporation and MILLER CHEMICAL & FERTILIZER CORPORATION, a Pennsylvania corporation (collectively, the “Debtors”).

WHEREAS, in connection with the Security Agreement dated April 30, 2007 (“SECURITY AGREEMENT”), as amended on September 17, 2009 (“FIRST AMENDMENT TO SECURITY AGREEMENT”), and as further amended on February 28, 2011 (“SECOND AMENDMENT TO SECURITY AGREEMENT”), (collectively, the “Agreements”), by and between Secured Parties and Debtors, said Security Agreement having been recorded at the United States Patent and Trademark Office on May 18, 2007 starting at Trademark reel/frame 3546/0492, said First Amendment to Security Agreement having been recorded at the United States Patent and Trademark Office on September 18, 2009 starting at Trademark reel/frame 4064/0316 and said Second Amendment to Security Agreement having been recorded at the United States Patent and Trademark Office on March 1, 2011, starting at Trademark reel/frame 4488/0198, wherein Debtors granted to Secured Parties, for the ratable benefit of the Secured Parties, a Security Interest in all of the following property then owned by such Debtor, or in which such Debtor at any time thereafter acquired, any right, title or interest, including, without limitation, the “Trademarks”, as that term is defined in the Security Agreement, and including, without limitation, the Trademarks listed on Schedule A attached hereto; and

WHEREAS, the Administrative Agent has agreed to release and discharge its Security Interest in the Trademarks, including, but not limited to, the Trademarks listed on Schedule A attached hereto.


Unless otherwise defined herein, terms which are defined in the Credit Agreement and used herein are so used as so defined.
