Assignment of Solis STILLMAN'S Mark

This Agreement is entered into by and between Gilda A. Solis, an individual and citizen of Mexico, having a mailing address at Calle San Pedro No. 9, Colonia La Joya, Tlalpan CP, Mexico DF, 14090, Mexico ("Assignor") and The Stillman Company, Inc., a corporation of Virginia having a principle place of business at 5613 Tower Hill Circle, Alexandria, VA22315 ("Assignee").

WHEREAS, Assignor is the owner of a trademark for STILLMAN'S ("said Mark") and currently an Intent To Use (ITU) United States trademark application therefor having a Serial No. 85/150,670 and filed on October 12, 2010 for goods in International Class 3, namely "Facial cream" ("said Trademark Application"); and

WHEREAS, Assignee wishes to acquire the entire rights, title, and interest in and to said Mark, said ITU Trademark Application, any goodwill associated with said Mark and the entire U.S. business associated therewith;

THEREFORE, the parties agree as follows:

1. Assignment. Assignor does hereby irrevocably sell, transfer and assign to Assignee all of its rights, title, and interest in and to said Trademark Application, said Mark, and all other marks that are confusingly similar thereto, in the United States and in every other country of the world, in the Madrid Protocol and Madrid Agreement, and in the Community Trademarks (CTM) in the Office for Harmonization in the Internal Market (OHIM), except Mexico, together with any goodwill associated therewith and of the entire U.S. business in connection with which said Mark is used, and together with all NAFTA, WTO, state and federal common law trademark, trade name, and trade dress rights therein, in and to said Mark.

2. Consideration. The consideration stated in the Settlement Agreement executed between the parties hereto and contemporaneous herewith.

3. Representations and Warranties. Assignor represents and warrants to Assignee:

- (a) Assignor has the right, power and authority to enter into this Assignment;
- (b) Assignor is the exclusive owner of all right, title and interest, including all intellectual property rights, in said Mark and said Trademark Application;
- (c) Said Mark and said Trademark Application are free of any liens, security interests, encumbrances or licenses;
- (d) Said Mark does not infringe the rights of any person or entity;
- (e) There are no claims, pending or threatened, with respect to Assignor's rights in said Mark and/or said Trademark Application;
- (f) This Agreement is valid, binding and enforceable in accordance with its terms in all jurisdictions pertaining hereto; and

(g) Assignor is not subject to any agreement, judgment or order inconsistent with the terms of this Assignment.
