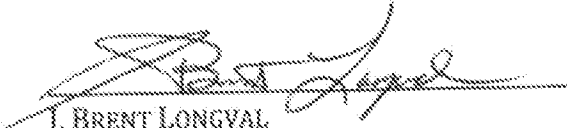
1. The name of the Company is now: MartFIVE LLC.
