Dear Commissioner:

Pursuant to §503.06(c) of the Trademark Manual of Examining Procedure, Rightful Owner submits the following declaration establishing that the recorded assignment from 4 Dynamics Investments LLC to Dynamic Ventures International LLC was unauthorized and invalid. Accordingly, Rightful Owner respectfully requests that the trademark records be appropriately corrected.

DECLARATION UNDER 37 C.F.R. § 2.20

I, Alfredo Ernesto Hoyos ("Declarant"), declare the following:

1) I was the sole owner and managing member of IC ABS LLC during all times pertinent to this declaration.

2) IC ABS LLC, a limited liability company organized under the laws of the state of Florida, was formerly the sole owner of the U.S. Trademark Application for the mark "4D" having serial no. 85/610,029 for "instructional services, namely, conducting classes and seminars in the field of liposculpting not utilizing ultrasonic

imaging technology" and for "liposculpting services not utilizing ultrasonic imaging technology" (hereinafter "the '029 application").

3) On April 15, 2013, IC ABS LLC was voluntarily dissolved, evidence of which is attached hereto as Exhibit A.

4) Nonetheless, after such time as IC ABS LLC was dissolved, an improper, untimely, and invalid assignment was recorded on August 21, 2013, against the '029 application at reel 5095, frame 0608.

5) Further, this purported assignment of the '029 application was conducted illegitimately by persons wholly lacking in authority or authorization to transfer or otherwise assign the '029 application.

6) To the contrary, the '029 application was transferred from the original Applicant, IC ABS LLC, to Declarant as of April 15, 2013, as is documented and confirmed via the nunc pro tunc assignment referenced in Exhibit B and recorded at reel 5192, frame 0691.


7) Accordingly, Declarant is the sole, true and correct owner of the '029 application and respectfully requests this to be reflected as such in the records of the U.S. Patent and Trademark Office.

8) All statements made herein are of my own knowledge, are true, are made on information and belief, and are believed to be true. Furthermore, these statements are made with the knowledge
