RELEASE OF TRADEMARK SECURITY INTEREST (005226/0780)

This **RELEASE OF TRADEMARK SECURITY INTEREST**, dated as of June 6, 2014, is made by SunTrust Bank, as administrative agent ("*Grantee*"), in favor of the Grantors party thereto the Trademark Security Agreement (as defined below).


WHEREAS, pursuant to the terms and conditions of (i) that certain Trademark Security Agreement, dated as of February 27, 2014 and recorded with the United States Patent and Trademark Office on February 28, 2014 at Reel 005226 Frame 0780 (the "*Trademark Security Agreement*"), made by the Grantors in favor of the Grantee, and (ii) the Guaranty and Security Agreement (as defined in the Trademark Security Agreement; hereinafter, the "*Security Agreement*"), Grantors pledged and assigned to Grantee, a continuing security interest in the trademarks and IP licenses listed on Schedule 1 attached hereto (collectively, the "*Trademarks*"), together with, among other things, the goodwill of the business symbolized by and associated with the Trademarks and the applications and registrations thereof, and all proceeds thereof (collectively, including the Trademarks, the "*Trademark Collateral*").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby (i) terminates the Trademark Security Agreement, and (ii) releases, without any representation, recourse or undertaking by Grantee, any and all liens on and security interests in the Grantors' Trademark Collateral granted pursuant to the Trademark Security Agreement and/or the Security Agreement, including the Trademark Collateral listed on Schedule 1 hereto.



