TERMINATION OF TRADEMARK SECURITY AGREEMENT

WHEREAS, JAMES LICENSING COMPANY, a Delaware corporation (“JLC”) having a mailing address of 2025 Joshua Road, Lafayette Hill, PA 19444, is the owner of the trademarks and registrations therefor (the “Marks”) listed on Schedule A hereto and the goodwill of the business associated therewith; and

WHEREAS, pursuant to a certain Trademark Security Agreement dated October 11, 2000, between JLC and FIRST UNION NATIONAL BANK, as successor by merger to CORESTATES BANK, N.A., and MERIDIAN BANK (“First Union”), JLC granted to First Union a security interest in and to the Marks, the registrations thereof, and the goodwill associated therewith;

WHEREAS, WELLS FARGO BANK, NATIONAL ASSOCIATION (“Wells Fargo”) with offices located at 123 South Broad Street, 7th Floor, Mail Code Y1379-073, Philadelphia, PA 19109, is the successor by merger to First Union National Bank; and

WHEREAS, the parties now desire to terminate Wells Fargo’s security interest in the Marks;

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises and other good and valuable consideration and intending to be legally bound hereby, Wells Fargo hereby agrees as follows:

1. Effective as of the date hereof, the above-referenced Trademark Security Agreement is hereby terminated, and of no further force or effect.
2. Wells Fargo, without recourse or warranty, hereby releases its security interest and conveys back to JLC all of Wells Fargo’s interest in and to the Marks, the registrations thereof and the goodwill associated therewith.

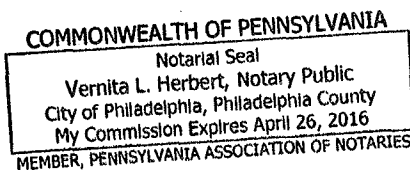
