RELEASE OF SECURITY INTEREST IN  
UNITED STATES TRADEMARKS

NOW, THEREFORE, for value received, Collateral Agent hereby releases, discharges, cancels and terminates all of its security interest in and to all of the trademarks and trademark registrations and applications of Grantor, including, without limitation, the trademarks and trademark registrations and applications listed on Schedule A attached hereto, and hereby re-assigns, re-transfers and re-conveys to Grantor any and all right, title or interest Collateral Agent may have in and to such trademarks and trademark registrations and applications, together with all of the goodwill associated therewith. Collateral Agent agrees to execute and deliver such further instruments and take or cause to be taken such other or further action as Grantor may reasonably request, and at Grantor's sole cost and expense, in order to perfect, confirm or evidence such release.
