**RELEASE OF SECURITY INTEREST

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “**Release**”), dated as of June 20, 2014, is made by JPMORGAN CHASE BANK, N.A., in its capacity as administrative agent (the “**Assignor**”), in favor of WILLIAMSON-DICKIE MANUFACTURING COMPANY, a Delaware corporation (the “**Assignee**”).

WHEREAS, the Assignee desires that the Assignor terminate and release its security interest in the Trademark Collateral;

NOW THEREFORE, the Assignor hereby **RELEASES**, without representation, recourse or warranty whatsoever, all of its security interest in the Trademark Collateral and the Assignor hereby reassigns any and all such right, title and interest that the Assignor may have in the Trademark Collateral to the Assignee.
