WHEREAS, pursuant to the terms of that certain Trademark Security Agreement dated as of July 15, 2011 (the "July 2011 Trademark Security Agreement"), by and between the Collateral Agent and the Grantor, as filed with the U.S. Patent and Trademark Office on July 20, 2011 at Reel 004587, Frame 00449, the Grantor granted to the Collateral Agent a security interest in and lien on all of its Collateral (as defined in the July 2011 Trademark Security Agreement);

WHEREAS, pursuant to the terms of that certain Trademark Security Agreement dated as of December 31, 2012 (the "2012 Trademark Security Agreement"), by and between the Collateral Agent and the Grantor, [as filed with the U.S. Patent and Trademark Office on August 29, 2013 at Reel 005100, Frame 0141, the Grantor granted to the Collateral Agent a security interest in and lien on all of its Collateral (as defined in the 2012 Trademark Security Agreement);

WHEREAS, pursuant to the terms of that certain Trademark Security Agreement dated October 4, 2013 (the "2013 Trademark Security Agreement" and collectively with the 2010 Trademark Security Agreement, the January 2011 Trademark Security Agreement, the July 2011 Trademark Security Agreement, and the 2012 Trademark Security Agreement, the "Security Agreements"), by and between Collateral Agent and the Grantor, as filed with the U.S. Patent and Trademark Office on November 19, 2013 at

Reel 005157, Frame 0194, the Grantor granted to the Collateral Agent a security interest in and lien on all of its Collateral (as defined in the 2013 Trademark Security Agreement); and

WHEREAS, the Collateral Agent wishes to release the security interest in and lien on the all of the Collateral, including, without limitation, the trademarks identified on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent states as follows:

The Collateral Agent hereby terminates and releases its security interest in and lien on the Collateral as set forth in the Security Agreements, and the Collateral Agent hereby assigns and transfers to the Grantor, without recourse, all of its right, title and interest in and to the Collateral, including, without limitation, each of the trademarks identified on Schedule A attached hereto, effective as of the date set forth above.

The Collateral Agent understands and agrees that this Release may be recorded by or for the Grantor with the U.S. Patent and Trademark Office or any similar office or agency within or outside the United States.
