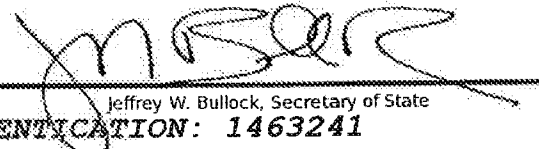

**CERTIFICATE OF AMENDMENT
TO THE
CERTIFICATE OF INCORPORATION
OF
CAMPUS SENTINEL, INC.**

The undersigned, on behalf of Campus Sentinel, Inc., a corporation organized and existing under the laws of the State of Delaware (the "Corporation"), DOES HEREBY CERTIFY:

FIRST: That pursuant to a joint written consent resolution executed by all members of the Corporation's Board of Directors and by the holders of a majority of the Corporation's outstanding voting shares, the following resolutions were duly adopted and approved setting forth a proposed amendment to the Certificate of Incorporation. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that the Certificate of Incorporation of the Corporation shall be amended by amending Article "First" so that, as amended, said Article shall be and read as follows:

"The name of the corporation is Social Sentinel, Inc."

RESOLVED, that the Certificate of Incorporation of the Corporation shall be amended by filing a Certificate of Amendment to the Certificate of Incorporation (the "Certificate of Amendment") so that, as amended, the Article Fourth shall be and read as follows:

"The total number of shares of stock which the Corporation shall have the authority to issue is One Million Four Hundred Thousand (1,400,000) shares of Common Stock, \$0.001 par value per share."

SECOND: That thereafter, pursuant to a written consent in lieu of meeting duly executed in accordance with Section 228 of the DGCL, the stockholders of the Corporation approved and adopted the Amendment.

THIRD: That the Amendment was duly adopted in accordance with the provisions of Section 242 of the DGCL.

FOURTH: That this Certificate of Amendment to the Certificate of Incorporation so adopted reads in full as set forth above. All other provisions of the Certificate of Incorporation remain in full force and effect.
