Short Form Agency Transfer Agreement

THIS SHORT FORM AGENCY TRANSFER AGREEMENT, dated as of January 9, 2014 (this "Short Form Agreement"), is made by and between CP Admin Co LLC, as the resigning administrative agent, collateral agent and custodian (the "Resigning Agent") and MC Admin Co LLC, as the new administrative agent, collateral agent and custodian (the "New Agent"). All capitalized terms not defined herein shall have the meanings ascribed to them in the Credit Agreement (as defined below).

WITNESSETH:

WHEREAS, Parent, the Borrower, the Lenders party thereto and the Resigning Agent have entered into a Credit Agreement, dated as of November 28, 2012 (as amended, supplemented or otherwise modified from time to time, the "Existing Credit Agreement");

WHEREAS, Parent, the Borrower, the Lenders and the New Agent have entered into Amendment 2 to Credit Agreement (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") pursuant to which Parent, the Borrowers, the Lenders and the New Agent are amending and restating the Existing Credit Agreement and the Lenders are appointing the New Agent as Administrative Agent thereunder and under the other Loan Documents, including the Security Agreements (as defined below);

WHEREAS, pursuant to the Existing Credit Agreement, certain guarantors have entered into those certain trademark and patent security agreements, copies of which are attached hereto ("Security Agreements"), through which the Resigning Agent was granted a security interest in the Trademark Collateral and Patent Collateral (each as defined in the Security Agreements); and such Security Agreements were recorded with the United States Patent and Trademark Office ("PTO");

WHEREAS, the New Agent wishes to acknowledge its appointment as Administrative Agent under the Security Agreements and its assumption of the rights, powers, privileges and duties of the Administrative Agent thereunder;

WHEREAS, the Resigning Agent, in connection with the appointment of the New Agent as Administrative Agent under the Credit Agreement, wishes to resign from its position as administrative agent and collateral agent under the Security Agreements; and

WHEREAS, this Short Form Agreement is intended to confirm the appointment of the New Agent as Administrative Agent under the Security Agreements and be recorded with the PTO or other appropriate government authorities.

NOW, THEREFORE, IT IS AGREED:

As of the date hereof, (a) the Resigning Agent hereby confirms its resignation, release and discharge from any responsibilities or obligations as administrative agent and collateral agent under the Security Agreements and (b) the New Agent hereby acknowledges and accepts its appointment as Administrative Agent under the Security Agreements and its assumption of the rights, powers, privileges and duties of the Administrative Agent thereunder.

This Short Form Agreement may be recorded with the PTO or any other government offices as desired by the New Agent.

This Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
