Trademark Assignment

THIS TRADEMARK ASSIGNMENT ("Agreement"), dated as of February 20, 2014, is entered into by and between Wet-N-Stick LLC d/b/a Dura-Tape International ("Assignor"), a New Jersey limited liability company having a place of business at 341 Wyoming Avenue, Millburn, New Jersey 07041, and Echelon Corporation ("Echelon"), a New York corporation, having a place of business at 890 Route 35, Cross River, New York 10518 ("Assignee").

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to acquire from Assignor, Assignor's right, title and interest in and to: (a) the mark "WET N STICK", together with U.S. Trademark Registration No. 3,452,446, and any and all goodwill of the business symbolized thereby; (b) the mark "Dura-Tape", in any and all forms, including without limitation "Dura-Tape", and any and all goodwill of the business symbolized thereby; (c) the mark "Aqua Tape", in any and all forms, and any and all goodwill of the business symbolized thereby; (d) the mark "Hydro Joint Tape", in any and all forms, and any and all goodwill of the business symbolized thereby; and (e) the mark "Blazeblocker", in any and all forms, and any and all goodwill of the business symbolized thereby; (collectively, the "Trademarks")

NOW THEREFORE, for and in consideration of the covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby irrevocably convey, sell, transfer, assign and deliver to Assignee all right, title and interest throughout the world in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks, to be held and enjoyed by Assignee for its own use and benefit, and for the use and benefit of its affiliates, successors, assigns and legal representatives, to be held as fully and entirely as such rights would have been held and enjoyed by Assignor had this Assignment not been made.

AND, the rights assigned hereunder specifically include, without limitation, the entire right, title and interest in and to any claims, in law or equity, and the right to sue for any and all past, present or future infringement or unauthorized use of the Trademarks and to receive any and all recoveries or damages arising there from, and Assignee shall have all right to extend, renew, maintain, defend and enforce the Trademarks in its own name in the United States and any foreign country.

AND, Assignor hereby agrees, at Assignee's request, to execute any documents and to perform any acts deemed necessary or convenient to vest or record title in and to the Trademarks in Assignee and/or to extend, renew, maintain, defend and enforce the Trademarks.

AND, Assignor hereby confirms and acknowledges that Assignee shall have sole and absolute discretion with respect to maintaining, defending and enforcement of the Trademarks.

AND, Assignor shall promptly transfer to Assignee all files related to the Trademarks.
