TRADEMARK RELEASE

This Trademark Release is made as of June 12, 2014, by General Electric Capital Corporation, as administrative agent ("Agent") in favor of Cincinnati Test Systems, Inc., an Ohio corporation, and AW Company, a Delaware corporation (together, the "Grantor").

WITNESSETH:

WHEREAS, Grantor and Agent are parties to that certain Trademark Security Agreement dated as of July 24, 2012 (the "Agreement"; capitalized terms which are not defined herein have the meaning given to such terms in the Agreement) and pursuant to which Grantor granted a security interest to Agent in the Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent;

WHEREAS, the Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on July 12, 2012, at Reel 4827, Frame 0977;

WHEREAS, Grantor has requested that Agent release its security interest all of Grantor's right, title and interest in and to the Trademark Collateral; and

WHEREAS, Agent has agreed to release the entirety of its security interest in all of Grantor's right, title and interest in and to the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the following, whether then owned or existing or thereafter created, acquired or arising (collectively, the "Trademark Collateral"):


- a) each Trademark listed on Schedule A annexed hereto, together with any renewals or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- b) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Agent hereby authorizes the Grantor (or the Grantor's authorized representative(s)) to record this Trademark Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency in order to accomplish the release of the Agent's security interest as described herein.
