**TRADEMARK RELEASE**

This Trademark Release is made as of June 12, 2014, by General Electric Capital Corporation, as administrative agent ("Agent") in favor of Air Logic Power Systems, LLC, a Wisconsin limited liability company ("Grantor").

**W I T N E S S E T H:**

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the following, whether then owned or existing or thereafter created, acquired or arising (collectively, the "Trademark Collateral"):



- b) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

Agent hereby authorizes the Grantor (or the Grantor's authorized representative(s)) to record this Trademark Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency in order to accomplish the release of the Agent's security interest as described herein.
