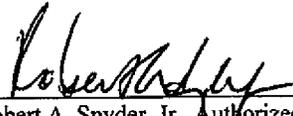
SECOND: The name of the limited liability company (herein the "Company") is:

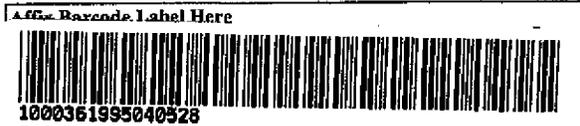
