RELEASE OF INTELLECTUAL PROPERTY COLLATERAL LIEN

This RELEASE OF INTELLECTUAL PROPERTY COLLATERAL LIEN (this "Release"), dated as of August 3, 2012, is made by ATALAYA ADMINISTRATIVE LLC, (in its individual capacity, "Atalaya Administrative"), in its capacity as successor to CapitalSource Finance LLC as administrative, payment, and collateral agent for the Lenders from time to time parties to that certain Credit Agreement described below (Atalaya Administrative, in such capacity, hereinafter is referred to as the "Secured Party").

RECITALS:

A. SiTV, Inc., a Delaware corporation ("Borrower"), SiTV Media, Inc., a Delaware corporation ("Holdings"), JAAM Productions, LLC, a Delaware limited liability company ("JAAM"), SCN Distribution, LLC, a Delaware limited liability company ("SCN"), and Latino Events LLC, a Delaware limited liability company ("Latino Events") (Borrower, Holdings, JAAM, SCN, and Latino Events sometimes hereinafter are referred to collectively as the "Credit Parties"), the financial institutions from time to time parties thereto, as Lenders thereunder, and the Secured Party entered into that certain Credit Agreement dated as of January 3, 2007 (such Credit Agreement, as the same has been amended, modified, supplemented, extended, renewed, restated, and/or replaced from time to time, hereinafter is referred to as the "Credit Agreement").

B. The Credit Parties issued an Acknowledgement of Intellectual Property Collateral Lien dated as of May 27, 2010 and recorded in the U.S. Copyright Office on June 16, 2010, at Volume 3591, Document 28 (the "Recorded Lien") with respect to the registered trademarks, copyrights, and patents identified on Schedules I, II, and III attached hereto (the "Registered IP") pursuant to which the Credit Parties granted a security interest in the Registered IP to the Secured Party.

C. The Credit Parties have refinanced their debt owing to the Lenders in full. Secured Party is executing and delivering this Release in order to evidence the release all of Secured Party's right, title, and interest in and to the Registered IP.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, Secured Party does hereby (i) release the Recorded Lien and all of its right, title, and interest in and to the Registered IP, and (ii) grant, assign, sell, and convey unto the registered holder of the Registered IP, without recourse, representation, or warranty, all right, title, and interest in and to the Registered IP which Secured Party now has or heretofore may have acquired by virtue of the Recorded Lien.



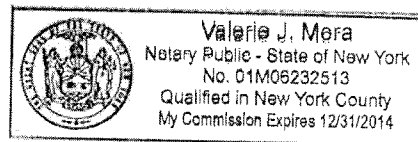
