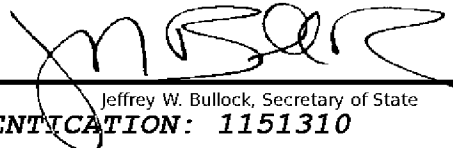

FIRST: The name of this corporation is Solum, Inc. (the "**Company**").

SECOND: The date of filing of the original Certificate of Incorporation of the Company with the Secretary of State of the State of Delaware was May 22, 2009 (the "**Certificate**").
