## DEED OF TRANSFER

This DEED OF TRANSFER of the trademark and the registration thereof listed on Schedule A attached hereto (the "**Deed**"), dated as of May 16, 2014 is by and among SweetWorks, Inc., a Delaware corporation (the "**Assignor**"), and SweetWorks Confections LLC, a Delaware limited liability company (the "**Assignee**").

### RECITALS

A. Pursuant to the terms of a certain U.S. Asset Contribution Agreement dated as of April 6, 2014 (the "**ACA**") among the Assignor, Assignee and Philip Terranova, Assignor is desirous of transferring all of its right, title, and interest in and to the trademark and the registrations thereof listed on Schedule A attached hereto (the "**Trademark**").

**NOW, THEREFORE**, in consideration of the terms of the ACA, and other good and valuable consideration, the receipt and sufficiency of which are acknowledged, Assignor hereby grants, conveys and assigns to Assignee all of Assignor's right, title, and interest in and to the Trademark and registrations thereof, together with (i) all income, royalties, damages and payments now and later due and payable with respect to the Trademark, including, without limitations, damages and payments now and later for past, present or future infringements; (ii) the right to sue for past, present and future infringements; (iii) all rights to such Trademark; and (iv) the good will of the business associated with and symbolized by the Trademark and registrations. Assignor covenants that it shall execute any other documents and perform any other acts that may be necessary fully to vest in Assignee the rights conveyed by this Deed. Nothing in this Deed shall be deemed to modify, amend or alter any of the representations, warranties and covenants contained in ACA, all of which survive the execution and delivery of this Deed. This Deed shall be binding upon Assignor, its successors and assigns, and shall inure to the benefit of Assignee, its successors and assigns. This deed shall be governed by and construed in accordance with the law of the State of New York (without giving effect to conflicts of law principles thereof) and, where appropriate, applicable federal law.
