**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 16, 2014 ("Release"), is made by PNC Bank, National Association, as Agent ("Agent") in favor of Polyester Fibers, LLC ("Grantor").

WHEREAS, pursuant to that certain Revolving Credit and Security Agreement dated as of October 21, 2011 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among Grantor, the Agent and others party thereto, the Grantor granted to the Agent, for its benefit and the benefit of the Lenders ("Secured Parties"), a continuing security interest in, and a right to set off against, any and all right, title and interest of the Grantor in, to, and under all the trademarks, trademark applications, and all products and proceeds of the foregoing ("Trademark Collateral");

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered to Agent, for its benefit and the ratable benefit of the Secured Parties, the Notice of Grant of Security Interest in Trademarks dated as of October 21, 2011 ("Notice"); and

WHEREAS, the Notice was recorded at the United States Patent and Trademark Office ("USPTO") on October 27, 2011 at Reel 4649 Frame 0511.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent, on behalf of the Secured Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

SECTION 2. Termination and Release. Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under all the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of Florida.

IN WITNESS WHEREOF, the Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
