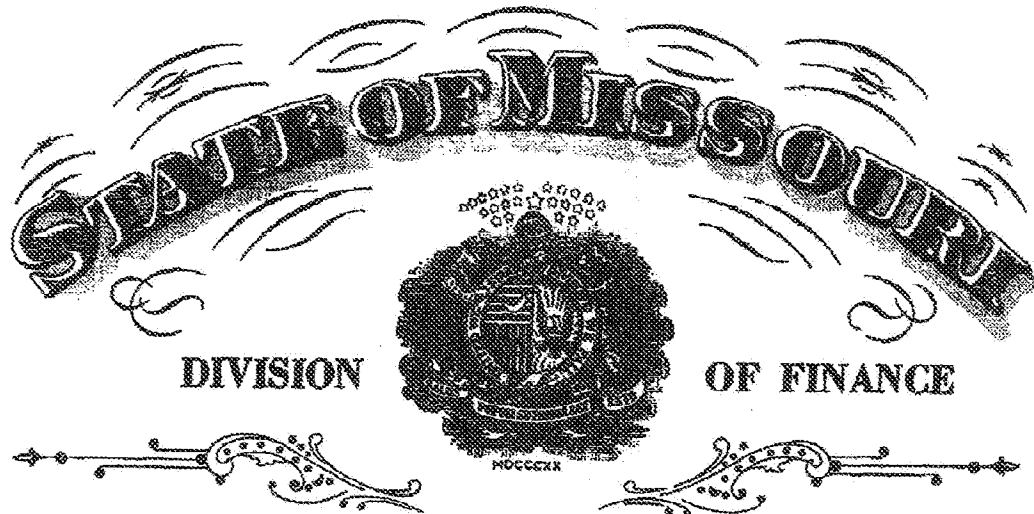

## ORDER

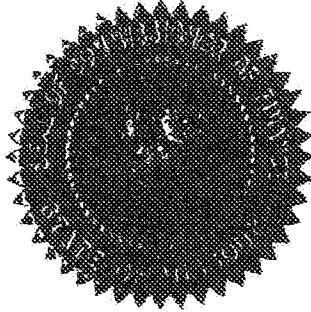
*WHEREAS*, there was filed in this office a certified and verified copy of an agreement to merge *COUNTRY CLUB BANK, N. A., SHAWNEE MISSION, JOHNSON COUNTY, KANSAS*, with and into *NORBANK, NORTH KANSAS CITY, CLAY COUNTY, MISSOURI*, under the Articles of Agreement of *NORBANK*, with the surviving bank issued a trust company charter under Charter No. 342 and renamed *COUNTRY CLUB BANK*; and

*WHEREAS*, pursuant to said agreement of merger, the main banking house of the surviving bank shall be located at *414 NICHOLS ROAD, KANSAS CITY, JACKSON COUNTY, MISSOURI*; and

*WHEREAS*, it has been determined that the agreement to merge the aforesaid banks in all respects complies with Section 362.630, RSMo Cum. Supp. 2008, and that the banks are wholly owned by the same bank holding company so that the merger shall take effect upon the issuance of this certificate as prescribed by Section 362.680, RSMo Cum. Supp. 2008.

*NOW, THEREFORE, I, RICHARD J. WEAVER*, Deputy Commissioner of Finance (deputy director of the Division of Finance) of the State of Missouri, certify

that on this third day of April, Two Thousand and Nine, pursuant to the authority contained in Section 362.670, I determined that the aforesaid agreement for merger should be and it is hereby approved.
